Mr Gresham has asked about skill sets of our band parents to help reduce the cost of the building. Wed morning will be rehearsal with the grade school bands then in the evening will be the concert with the grade schools and the high school concert band.

**Treasurer's report:** Treasurer's report was read by Angie Perry and Michelle Johnson. It was motioned by Randy Cornelison and properly seconded by Stephen Cordes to approve. Highlights of the report include that our operating is 18,435.69 but the true balance is 2,792.93 due to 15,642.76 is student savings.
